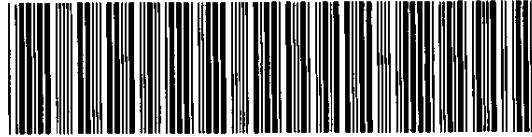

The Articles of Organization for this Limited Liability Company were originally filed on October 2, 2013 and assigned Florida document number L13000139271.

- A. This Limited Liability Company will hence forth be a Professional Limited Liability Company pursuant to chapter 621 of the Florida Statutes.
- B. Articles I of the Article of Organization is Amended and the name of the Limited Liability company is changed to J.C.E. FAMILY MEDICINE, PLLC. to reflect the entity being a Professional Limited Liability Company. pursuant to chapter 621 of the Florida Statutes.
- C. Article III of the Articles of Organization is amended as follows:
The purpose for which this Professional Limited Liability Company is organized is:
 - a. To engage in the practice of medicine as a Professional Limited Liability Company and to own and operate a medical clinic for the purpose of providing medical care and treatment.
 - b. To promote medical, surgical, and scientific research and knowledge; to furnish related laboratory and clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional medical services.
 - c. To do everything necessary, proper, or convenient to accomplish any of the purpose set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these Articles of Organization.

The purposes of this Limited Liability Company shall be carried out only through members, managers, employees, and agents each of whom is licensed or otherwise legally qualified to render professional medical services in the State of Florida.
