# J.C.E. FAMILY MEDICINE, LLC

The Articles of Organization for this Limited Liability Company were originally filed on October 2, 2013 and assigned Florida document number L13000139271.

- A. This Limited Liability Company will hence forth be a Professional Limited Liability Company pursuant to chapter 621 of the Florida Statutes.
- B. Articles I of the Article of Organization is Amended and the name of the Limited Liability company is changed to J.C.E. FAMILY MEDICINE, PLLC, to reflect the entity being a Professional Limited Liability Company, pursuant to chapter 621 of the Florida Statutes.
- C. Article III of the Articles of Organization is amended as follows:
