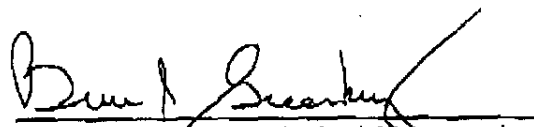
**ARTICLE IV**
