RESTRICTIONS ON MEMBERSHIP





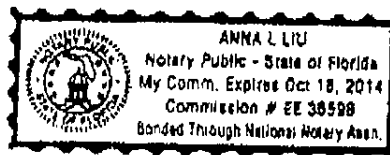
