ARTICLES OF ORGANIZATION JONATHAN W. MARSH, M.D., P.L.

The undersigned, for the purposes of forming a professional limited liability company under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME
