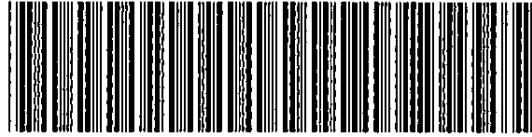

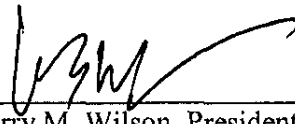

The name of the limited liability company is: SIX/TEN, LLC.

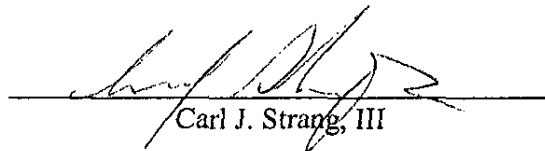
