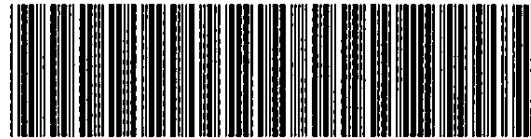

The name of the limited liability company shall be **Luck Duck Palm Beach, LLC.**




