Articles of Organization for TARUD, LLC

The undereigned; being duly authorized to act as the organizer of this Limited Liability Company pursuant to Chapter 608 Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for said Limited Liability Company.

ARTICLEL-NAME

ARTICLE VIII -- TRANSFER OF OWNERSHIP RIGHTS

A Momber may transfer an ownership interest in the Company, including voting rights, without the consent of any other Member of the Company, providing however, the transfer complies with all applicable requirements under Florida law.

ARTICLE IX - LIMITATION ON AGENCY AUTHORITY OF MEMBERS


