ARTICLES OF ORGANIZATION

OF

ZEUS PROPERTIES FOUR, LLC

The undersigned, being a duly authorized representative of a Member, desiring to form limited liability company under and pursuant to the Florida Limited Liability Company Act, chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization and hereby certifies:

ARTICLE I: NAME

ARTICLE VIII: REGULATIONS
