ARTICLES OF ORGANIZATION OF GASTON FARM, LLC

(a Florida limited liability company)

The undersigned, LAURIE H. GASTON, a natural person competent to contract and member of GASTON FARM, LLC, hereby presents these Articles of Organization as the Articles of Organization of GASTON FARM, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I- NAME

The name of the limited liability company is GASTON FARM, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE 11- PRINCIPAL OFFICE ADDRESS

The mailing and street address of the principal office of the Company \$\frac{1}{12} \cdot 2308-Malysa Place, Pensacola, FL 32504.

ARTICLE III- PURPOSES AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights a limited liability company may exercise under the Florida Limited Liability Company Act.

ARTICLE IV- COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date of filing of these Articles of Organization with the Florida office of the Secretary of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V- REGISTERED OFFICE AND AGENT

The registered office of the Company is 2308 Malysa Place, Pensacola, FL 32504, and the name of the registered agent at that address is Laurie H. Gaston.

ARTICLE VI- MANAGEMENT

The Company shall be managed by a manager who may or may not be a member in accordance with the terms of the Operating Agreement of the Company. Laurle H. Gaston shall serve as the initial Manager of the Company.

ARTICLE VII- AMENDMENT

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.
