**ARTICLES OF ORGANIZATION  
OF  
SERVICIOS FINANCIEROS INTCOMEX LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

**ARTICLE I. NAME**

The name of the limited liability company is Servicios Financieros Intcomex LLC (the "Company").

**ARTICLE II. MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be 3505 NW 107<sup>th</sup> Avenue, Doral, Florida 33178, Attn: Humberto Lopez.

**ARTICLE III. REGISTERED AGENT AND OFFICE**

The Company shall be a manager-managed limited liability company and shall be managed in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The initial Manager of the Company shall be Humberto Lopez.
