ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

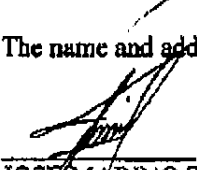
