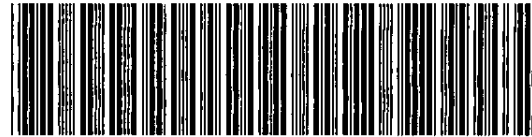

**Articles of Organization**

**Of**

**TRINITY GUIDE SERVICE, LLC**

**A Florida Limited Liability Company**

The undersigned (the "Member") acting as the organizer of Trinity Guide Service, LLC under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization.

**Article 1**

**Name**

The name of the limited liability company is Trinity Guide Service, LLC (the "Company").

**Article 2**

**Period of Duration**

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

**Article 3**

**Purposes, Powers and Capital Contributions**

- A. Purposes. The Company is organized to provide fishing guide services to the public. The Company is also organized for, and may engage in, any other lawful purposes.
- B. Powers. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.
- C. Capital Contributions. The Members shall make contributions from time to time, as required by the Operating Agreement adopted by the Company.

**Article 4**

**Effective Date**

These articles shall be effective upon filing.

**Article 5**  
**Address of Place of Business**

The mailing address for the Company is 4700 Rummell Road, St. Cloud, Florida 34771 and the street address of the place of business for the Company is 4700 Rummell Road, St. Cloud Florida 34771. These addresses may be changed from time to time as provided in the Operating Agreement.

**Article 6**  
**Registered Agent**

The initial registered agent in Florida for the Company is Robert S. Hensel and the initial registered office is located at 4700 Rummell Road, St. Cloud, Florida 34771.

**Article 7**  
**Members**

The Company shall have at least one member and may admit additional members on the prior unanimous agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

**Article 8**  
**Continuity of Business**

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or on the occurrence of any other event that terminates the continued membership of a Member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all remaining Members of the Company.

**Article 9**  
**Management**

The overall management and control of the business and affairs of the Company shall be vested in its members, as provided in these Articles of Organization and section 608.407 of the Act. Any and all action by the Company shall require the vote of members holding a majority interest in the Company.

**Article 10**  
**Indemnification**

Except as expressly provided in the Operating Agreement, the Company shall indemnify any Member, manager, or former Member or manager to the full extent permitted under the Act.

**Article 11**  
**Adoption of Operating Agreement**

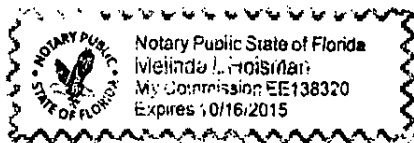
The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608, Fla. Stat.
