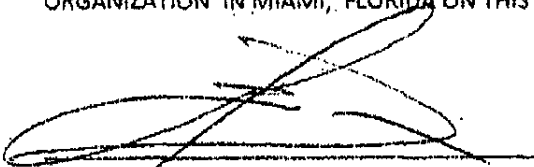
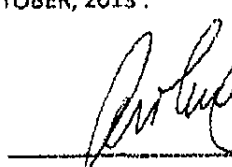
ARTICLE VIII – TERMINATION OF EXISTENCE
