ARTICLES OF ORGANIZATION

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, **AMBITION HOUSE, LLC**, a Florida limited liability company ("*Company*"), through the undersigned, as its authorized representative, certifies that:

A. The Articles of Organization of the Company were filed by the Florida Department of State on October 23, 2013, and assigned Florida document number L13000149545.

B. The Articles of Organization are hereby amended and restated in their entirety to read as follows:

1. NAME. The name of the Limited Liability Company is: **AMBITION HOUSE, LLC**.
