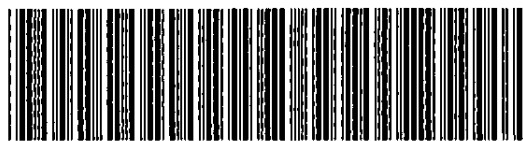

Article IV

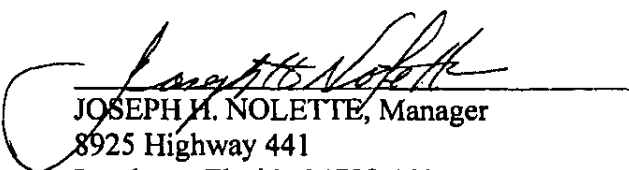

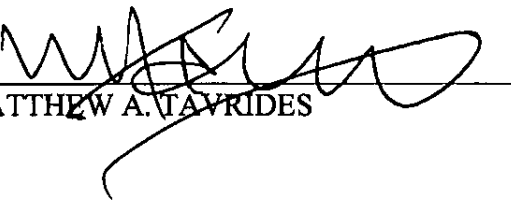
