The name of the Limited Liability Company shall be GAEMA, LLC (the "Company").

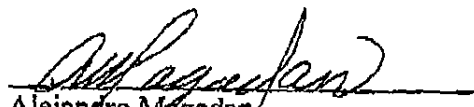
ARTICLE II - Nature of Business and Mailing Address:

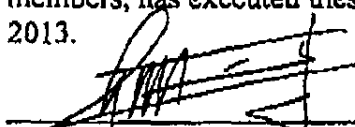
