**FIFTH**, the net assets of the Limited Liability Company remaining, if any, after winding up have been distributed to the Members;

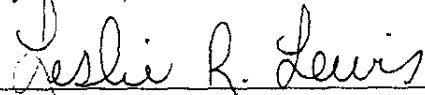
**SIXTH**, the Limited Liability Company is current with its federal income tax reporting requirements to the Internal Revenue Service;
