**ARTICLES OF ORGANIZATION  
OF  
AQUAT, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes acknowledges and files the following Articles of Organization (the "Articles").

**ARTICLE I  
NAME**

The name of the limited liability company is AQUAT, LLC (the "Company").

**ARTICLE II  
MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be 20584 N.E. 6<sup>th</sup> Court, Miami, Florida, North Miami Beach, Florida, Florida 33179.

**ARTICLE III  
REGISTERED AGENT AND OFFICE**

**ARTICLE IV  
DURATION**

The Company shall commence its existence on the date that the Articles are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in the Operating Agreement.

The Company shall be a manager managed limited liability company. The initial managing members shall be ERAN EFRAT, SHIMON FITOUSSI, YOGEV A. MALUL, and JUSTIN H. NOVAK.

Profits and losses shall be allocated to the members, as provided in the Operating Agreement, duly adopted and as amended from time to time by the members.


**ARTICLE VII

A member may transfer his, her or its interest in the Company, as set forth in the Operating Agreement, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member, unless the other members of the Company other than the member proposing to dispose of his, her or its interest approve of the proposed transfer in accordance with the requirements set forth in the Operating Agreement.

AMENDMENT**


The Articles may be amended only in accordance with the Operating Agreement.
