The Limited Liability Company shall have one (1) member initially. The name of the member and their respective interests in the Limited Liability Company is as follows:



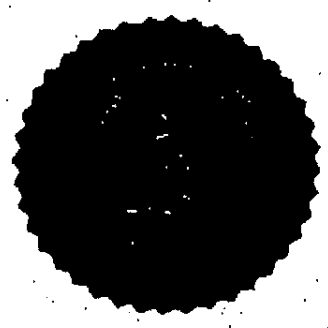
