The undersigned, BERNICE R. SHANKLIN, a natural person competent to contract and a member of BJRS INVESTMENTS, LLC, hereby presents these Articles of Organization as the Articles of Organization of BJRS INVESTMENTS, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is BJRS INVESTMENTS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address and mailing address of the principal office of the Company is 950 Bay Drive, Niceville, Florida 32578.

ARTICLE III - PURPOSES AND POWERS

The Company is organized for any legal and law purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, as such chapter presently exists and may hereafter be amended.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

The address of the registered office of the Company is 950 Bay Drive, Niceville, Florida 32578, and the name of the registered agent at that address is Charles R. Shanklin.

ARTICLE VI - MANAGEMENT

The Company shall be a manager-managed limited liability company and will be managed in accordance with the terms of the Operating Agreement for the Company.

ARTICLE VII - AMENDMENT

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.

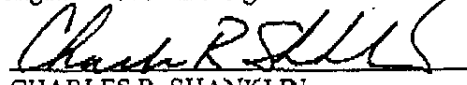
