AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR J.A. SAL HOLDINGS, LLC

The Articles of Organization for J.A. Sal Holdings, LLC, which Articles of Organization were originally filed on October 3, 2013, are being amended and restated, in their entirety, to provide, among other things: (i) provide for the issuance of 1,000 Units of membership interest, which units shall evidence the interest of the Members of the Limited Liability Company; (ii) provide that the Limited Liability Company shall be managed by a board of managers; (iii) provide for a limitation on distributions; and (iv) provide for the Managers of the Limited Liability Company to hold offices. This Amended and Restated Articles of Organization was adopted by written consent of all of the Members and Managers of the Limited Liability Company, entitled to vote thereon, pursuant to Florida Limited Liability Company Act Section 608.411, on January 9, 2019. ARTICLE I - NAME

The name of the Limited Liability Company is J.A. SAL HOLDINGS, L.L.C.

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The period of duration for the Limited Liability Company shall be perpetual.

ARTICLE IV - MEMBER UNITS

The Limited Liability Company is authorized to issue 1,000 Units of membership interest, which Units shall evidence the interest of the members of the Limited Liability Company, which Units shall be designated "Member Units." The interest of the members of the Limited Liability Company shall be evidenced by the Certificate of Limited Liability Company Units issued by the Limited Liability Company and setting forth the number of Member Units issued and outstanding in the name of such member.

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning one-hundred (100%) percent of the outstanding Member Units of the Limited Liability Company. In such event, the terms and conditions for the admission of additional members, together with the capital contributions required of new members, shall be determined at that time by a vote of the members owning one-hundred (100%) percent of the outstanding Member Units of the Limited Liability Company. A member's interest in the Limited Liability Company may not be sold or otherwise transferred except upon the approval of members owning one-hundred (100%) percent of the issued and outstanding Member Units of the Limited Liability Company.

ARTICLE VIII - WITHDRAWAL; RETURN OF CAPITAL

The Members of the Limited Liability Company shall have the right to withdraw as a member with (i) six (6) months prior notice, and (ii) with the consent of Members owning one-hundred (100%) percent of the Member Units of the Limited Liability Company. Likewise, there shall be no return of all or a portion of the contributed capital without the consent of Members owning one-hundred (100%) percent of the Member Units of the Limited Liability Company.

ARTICLE IX - DISTRIBUTION

The purpose of the Limited Liability Company is to engage in one or more businesses and/or to invest and reinvest its assets. Accordingly, no distribution is contemplated. Notwithstanding the foregoing, the Board of Managers and Members owning one-hundred (100%) percent of the Member Units of the Limited Liability Company may consent to a distribution, All distributions shall be in the form of insurance company annuity contracts with the respective member as the annuitant, unless the Board of Managers and Members owning one-hundred (100%) percent of the Member Units of the Limited Liability Company consent of the wise.

ARTICLE X - OFFICERS

The managers shall hold those offices and have those responsibilities accorded to them by the members of the Limited Liability Company, as set forth in the Regulations of the Limited Liability Company.

ARTICLE XI - AMENDMENT OF ARTICLES OF ORGANIZATION

Members owning one-hundred (100%) percent of the Member Units of the Limited Liability Company may consent to an amendment to the Articles of Organization.

ARTICLE XII - INDEMNIFICATION

The Limited Liability Company shall Indemnify any member, manager or officer of the Limited Liability Company, or any former member, manager or officer of the Limited Liability Company, to the fullest extent permitted by law.
