**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned person, acting as the authorized representative of BAYROCK FAIRVIEW HEIGHTS EXCHANGE, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I - NAME**
