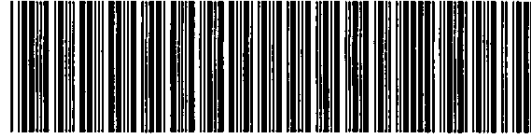




Ms. Hampton,




