ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF DPG 750 S. ORLANDO AVE LLC

The undersigned, authorized representative of the members of DPG 750 S. ORLANDO AVE LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company originally filed October 31, 2013, pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:
