ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF DPG 750 S. ORLANDO AVE LLC

The undersigned, authorized representative of the members of DPG 750 S. ORLANDO AVE LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company originally filed October 31, 2013, pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

- 1. The name of the Company is DPG 750 S. ORLANDO AVE LLC.
2. The date of the filing of the original Articles of Organization of the Company was October 31, 2013 (the "Articles of Organization") and the Florida Department of State issued the Company Document Number L13000153998.
3. Article VI of the Articles of Organization is hereby amended and restated in its entirety as follows:

"ARTICLE VI - REGISTERED OFFICE AND AGENT"

The Company hereby (i) designates 200 S. Orange Avenue, Suite 2300, Orlando, Florida 32801 as the street address of the Company's registered office, and (ii) names Scholars Fund Manager, LLC as the Company's registered agent at that address to accept service of process within the State of Florida."

- 4. Article VII of the Articles of Organization is hereby amended and restated in its entirety as follows:

"ARTICLE VII - MANAGEMENT AND AUTHORITY"

The Company shall be a manager-managed company. Pursuant to Section 608.4235, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member. The current manager of the Company is:


