The name and street address of the initial registered agent of the Company are Philippe Cesar, 2658 Oakington Street, Winter Garden, Florida 34787.

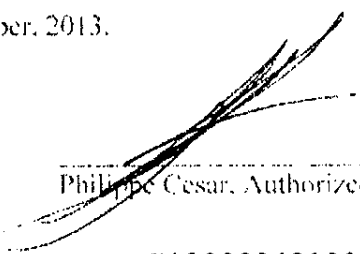
ARTICLE V. MANAGEMENT
