**ARTICLES OF ORGANIZATION
OF

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I

Name

The name of the limited liability company shall be **CIGAR CITY SALSA, LLC.**

ARTICLE II

Address and Place of Business

Period of Duration

Continuity of Business


