ARTICLES OF ORGANIZATION OF PET BUDDY RENTALS, LLC

The undersigned, for the purpose of forming a limited liability under the laws of the State of Florida, Limited Liability Company Act, Florida Statute Chapter 608 hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be **PET BUDDY RENTALS**, **LLC**, and its mailing address and principal office shall be located at 6820 Appaloosator., Lakeland, FL 33811, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
