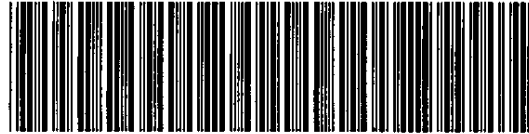

### **STATEMENT OF AUTHORITY**


