No part of the net earnings shall inure to the benefit of any individual, and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

ARTICLE VI
Dissolution

Upon a dissolution of the Company, the residual assets of the Company will be turned over to (a) its parent organization, if such organization remains exempt as an organization described in Sections 501(c)(3) and 170 (c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law, or (b), in the event the Company's parent organization fails to be so exempt, to (1) one or more organizations exempt under such IRC Sections or (2) to the federal, state, or local government for exclusive public purpose.
