ARTICLES OF ORGANIZATION

of

TK TEAKUN PREMIUM LLC (A Florida Limited Liability Company)

The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to Florida Statute, Chapter 608, hereby certifies:

ARTICLE I - NAME

The name of the limited liability company shall be TK TEAKUN PREMIUM LLC, hereinafter referred to as the "Company".

ARTICLE II - ADDRESS

The principal street address and mailing address of the Company is 7620 NW 25th Street, Suite 5, Miami, Florida 33122.

ARTICLE III - PURPOSE

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

ARTICLE IV - MANAGEMENT

The Company shall be managed by one or more members and is a member-managed Company. The initial manager of the Company shall be Seleucio Maldonado. The Operating Agreement may contain additional information or provisions concerning the management and regulation of the Company and its affairs, but shall not be inconsistent with the laws of the State of Florida or these Articles.

ARTICLE V - REGISTERED AGENT

The Registered Agent of the Company shall be Seleucio Maldonado. The address of the Registered Office is 7620 NW 25th Street, Suite 5, Miami, Florida 33122. The Registered Agent accepts this designation and agrees to comply with the provisions of Chapter 608 F.S. regarding the same.

ARTICLE VI - OWNERS

The initial members of the Company shall be:

Wilmer Jauregui (50% membership interest) - 7620 NW 25th Street, Suite 5, Miami, Florida 33122

Members of the Company may be added or removed, from time to time, as provided by law or in the Company's Operating Agreement.

ARTICLE VII - DURATION


The Company's duration shall commence upon the filing of these Articles with the Florida Department of State and shall continue in perpetual existence, unless earlier dissolved by operation of law or: (i) in accordance with the Company's Operating Agreement, or (ii) upon unanimous written consent of all the membership interests entitled to vote on such matters.

ARTICLE VIII - AMENDMENT

These Articles may be amended only as provided by law or in accordance with the Company's Operating Agreement.
