**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
W&W MOVING SOLUTIONS LLC**

Article V of the Articles of Organization of W&W Moving Solutions LLC was amended by the limited liability company's Members and Manager on March 18, 2014. The limited liability company is filing these Articles of Amendment to Articles of Organization pursuant to Florida Statutes Section 605.

1. The name of the limited liability company is W&W Moving Solutions LLC.

3. Article V of the Articles of Organization of the Company shall be amended to read as follows:

The Members of the Company shall adopt an operating agreement which shall contain provisions for the management of the business and the regulation of the affairs of the Company that are not inconsistent with the Articles or the laws of the State of Florida."

5. Article VIII shall be added to the Articles of Organization of the Company to read in its entirety as follows:

"ARTICLE VIII

The Company shall have the power to amend or supplement these Articles of Organization when approved by unanimous vote of the Members."

6. The foregoing amendments to the Articles of Organization were approved by unanimous vote of the Members and Manager.
