

These Articles of Organization (the "Articles") are made for the purpose of organizing a Florida Limited Liability Company (the "Company") under the Florida Limited Liability Act, as Amended (the "Act").

ARTICLE I – NAME

The name of this Limited Liability Company is GULFBREEZE ON 66TH, LLC.

ARTICLE II – MAILING ADDRESS

The mailing address and street address of the principal office of GULFBREEZE ON 66TH, LLC, is 309 59th Street, Unit B, Holmes Beach, FL 34217.

ARTICLE III – DURATION

The period of duration of GULFBREEZE ON 66TH, LLC shall be perpetual from the date of filing these Articles with the Department of State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE VI -- REGULATIONS


The members shall have the power to adopt, alter, amend or repeal regulations of GULFBREEZE ON 66TH, LLC.
