**ARTICLE III - Management**

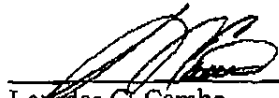
The Company shall be managed by its managers, as set forth in the Company's Operating Agreement, and is therefore a manager-managed company. The initial Manager is Caren Sredni.
