
**ARTICLES OF MERGER

These Articles of Merger are submitted in accordance with Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act"), with respect to the merger of **Columbia Prestige Motorcars, LLC**, a Florida limited liability company ("Columbia Prestige"), with and into **Columbia LR, LLC**, a Florida limited liability company ("Columbia LR"). Columbia LR is hereinafter sometimes referred to as the "Surviving Entity" and the merger that is the subject of these Articles of Merger are hereinafter referred to as the "Merger".

1. Columbia Prestige was first organized under the laws of the State of Florida on November 13, 2013.
2. Columbia LR was first organized under the laws of the State of Florida on November 13, 2013.
3. The Plan of Merger was approved by a Written Consent to Actions of the sole member of Columbia Prestige, dated as of the 21<sup>st</sup> day of August, 2015 in accordance with the applicable provisions of the Act.
4. The Plan of Merger was approved by a Written Consent to Actions of the sole member of Columbia LR, dated as of the 21<sup>st</sup> day of August, 2015 in accordance with the applicable provisions of the Act.
5. The Surviving Entity exists before the merger and is a domestic filing entity.
6. The Surviving Entity agrees to pay any members with appraisal rights the amount, to which members are entitled under Sections 605.1006 and 605.1061-605.1072, Florida Statutes.
7. The effective date of the Merger is the date of the filing of these Articles of Merger with the Florida Department of State.
