

**ARTICLES OF ORGANIZATION

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Covenant Business Solutions, LLC (the "Company"). 


**CERTIFICATE DESIGNATING**
