ARTICLES OF ORGANIZATION OF KINGS CROSS PROPERTIES, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, or statutes, or statutes, (the "Florida Limited Liability Company Act") for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

- 1. NAME. The name of the limited liability company is Kings Cross Properties, LLC (hereinafter referred to as the "Company").
- 2. <u>PERIOD OF DURATION.</u> The period of duration of the Company shall be from the date of filing of its Articles of Organization until the first to occur of the following:
 - (i) Dissolution of the Company pursuant to the provisions of the Florida Limited
 Liability Company Act; or
 - (ii) By the mutual written agreement of a majority in ownership interest of the members of the Company (each a "Member" and, collectively, the "Members"); or

- 6. MEMBERS. The Company shall have at least one (1) Member, and may admit additional Members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members (if any) of the Company.
- Managers. Any Manager may be (but is not required to be) a Member of the Company. Cooper, Jr. The Members may appoint one (1) or more additional Managers, or may replace the initial Manager named herein, in accordance with and in the manner provided for in the Operating Agreement.

9. **INDEMNIFICATION.** Except as expressly provided otherwise in the Operating Agreement, the Company shall indemnify any Member or former Member to the full extent permitted under the Florida Limited Liability Company Act.
