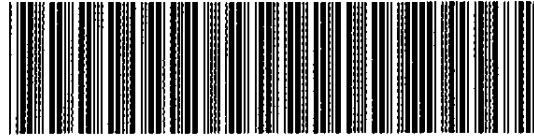

If a provision of these Articles of Organization differs from a provision of the Company's operating agreement, if any, then, to the extent allowed by law, the operating agreement will govern.

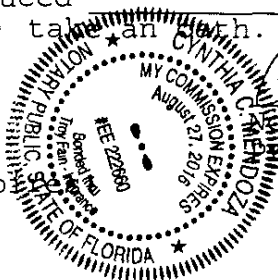


