ARTICLE V
MANAGEMENT

The Company shall be a manager-managed company and shall be governed by a written operating agreement executed by its members (the "Operating Agreement"). The managers of the Company shall be elected, removed and replaced from time to time in accordance with the Operating Agreement of the Company in effect from time to time. The sole initial manager shall be:



ARTICLE VI
RESTRICTIONS ON TRANSFER;
ADMISSION OF ADDITIONAL OR SUBSTITUTE MEMBERS

Among other things, the Operating Agreement restricts the sale, transfer, pledge, hypothecation, exchange, assignment or other disposition by any means (each, a "Transfer") of the membership interests in the Company. Any such Transfer shall be void *ab initio* unless made in strict compliance with the terms and conditions of the Operating Agreement. In addition, no person or entity shall be admitted as a member of the Company, whether in substitution for another member or as an additional member, except in accordance with the Operating Agreement.

ARTICLE VII
APPLICABLE LAW

The Company is created pursuant to Chapter 608, Florida Statutes, and shall be governed by the laws of the State of Florida.
