


**ARTICLES OF ORGANIZATION  
OF  
BNM VAN BUREN, LLC**

1. Name. The name of this limited liability company is BNM VAN BUREN, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.
3. Purpose. The Company is organized for the purpose of purchasing, owning real property including property at 3073 Van Buren Avenue, Naples, Florida 34112, buying and selling real property, leasing real property and transacting all lawful activities that may be conducted by a limited liability company under the laws of Florida.
