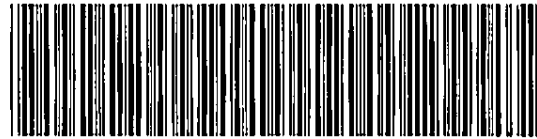

These are the Articles of Dissolution for Erod Investments, LLC., a Florida limited liability company.

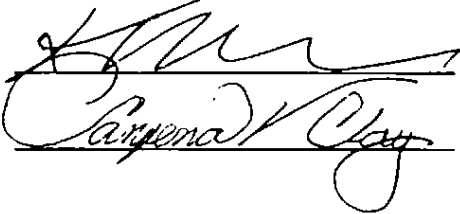
The original Articles of Organization were filed on 11-19-13 and were assigned document number LL000012348
