ARTICLES OF ORGANIZATION

The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company which was formed on by the filing of its Articles of Organization under the Chapter 608 of the Florida Statutes, does hereby adopt the following Amended And Restated Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:


DIXIE HIGHWAY 3542-3574, LLC

SECOND: The term of existence of the Limited Liability Company shall be perpetual.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Chapter 608 of the Florida Statutes, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The mailing address and street address of the initial registered office of the Limited Liability Company in Florida is 759 South Federal Highway, Suite 218, Stuart, Florida 34994, and the name of the initial registered agent of the Limited Liability Company to whom process may be sent in Florida at that address is Leonard Rutland, Jr.

FIFTH: The mailing address and principal office of the Limited Liability Company is 5299 DTC Boulevard, Suite 350, Greenwood Village, Colorado 80111.

SIXTH: The Limited Liability Company is to be managed by the Managing Members. The names and addresses of the initial Managing Members are: REMORA MANAGEMENT, LLC, a Colorado limited liability company, having an address at 5299 DTC Boulevard, Suite 350, Greenwood Village, Colorado 80111, and JOHN M. OLIVER, having an address at 1601 Grantham Drive, Wellington, Florida 33414

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Members is \$100.00. The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as may hereafter may be agreed by the unanimous vote of the Members. No additional capital contributions have been agreed to by the Members at this time.


NINTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members.

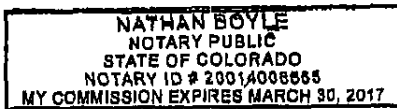
