

**ARTICLES OF ORGANIZATION
OF**

CONNOR WOODS, LLC

The undersigned persons hereby adopt these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE I – NAME

The name of this limited liability company shall be CONNOR WOODS, LLC (the “Company”).

ARTICLE II – DURATION

The Company shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE III – PURPOSE

The purpose of the Company is to engage in any lawful business activity that is not prohibited with respect to a limited liability company organized according to the laws of the State of Florida.

ARTICLE IV – ADDRESS

The initial street and mailing address of the principal place of business of the Company is 6395 Highway US 1, Rockledge, FL 32955.

ARTICLE V – REGISTERED AGENT

The number of the initial managers, who shall serve as managers until the first annual meeting of the Members of the Company or until their successors are duly elected, shall be two (2). 
ARTICLE IX – ADOPTION OF REGULATIONS


ARTICLE X – AMENDMENT
