**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
SKY SUPPORT, LLC**

The undersigned member of SKY SUPPORT, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), whose Articles of Organization were originally filed with the Florida Department of State on November 21, 2013, adopt the following Amended and Restated Articles of Organization of the Company by deleting Articles 1 through 9 of the Articles of Organization and replacing the Articles of Organization, in their entirety, with the following:

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The registered office of the Company shall be located at 14900 NW 42nd Street, Hanger 48 - Ste 106, Miami, Florida 33054, and the registered agent of the Company at such office shall be Fabio Alexander Vasquez. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV

Operating Agreement

The power to adopt the operating agreement of the Company, to alter, amend or repeal the operating agreement of the Company, or to adopt a new operating agreement, shall be vested in the

The operating agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.

Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.


