# ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be ASK TEXTILE SOLUTIONS-ŁLO ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company shall be 322/65 Surawongwattanakarn Building, Surawongse Road, Sipraya, Bangrak, Bangkok 10500, Thailand, and the mailing address shall be the same.
