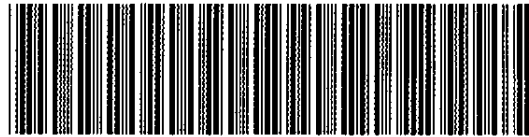

THIRD: The mailing address and street address of the principal office of the Limited Liability Company is 5114 Dr. Phillips Blvd., Orlando, FL 32819.

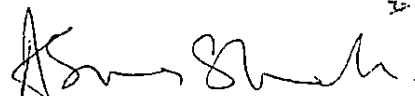
