ARTICLES OF ORGANIZATION OF MDW BAL HARBOUR INSURANCE, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida, Limited Liability Company Act. Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be MDW BAL HARBOUR INSURANCE, LLC. ("Company").
