**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

The Articles of Organization of Watercrest Lake Nona, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on November 26, 2013. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

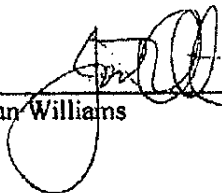
