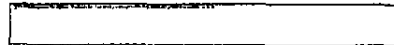

**ARTICLE III - REGISTERED AGENT**




